
# **Perception Equals Reality**

- How many workers are in Region 2's labor force?
  - 43,148 workers in 2018
  - (62.5% labor force participation rate)
    - Minnesota = 3,099,006 (69.9% lfpr)
- How many of these workers are Baby Boomers?
  - 11,142 workers between 53-71 years (26.9% of total)
    - Millennials (18-36 years) = 15,508 (37.4%)
- How many of these workers are non-white?
  - 7,526 workers of a different race or origin (18%)
    - Minnesota = 18.6%




# **Labor Force Trends**

- What do we know about these 43,148 workers?
  - Long-term trends up from 38,563 workers in 2000
  - Up from 29,853 workers in 1990 (+44.5%)
    - From 1990 to 2000, EDR 2 gained 8,710 workers (+29.2%)
    - From 2000 to 2010, EDR 2 gained 3,153 workers (+8.2%)
    - From 2010 to 2018, EDR 2 gained 1,432 workers (+3.4%)



#### **Labor Force Trends**

- Relatively high unemployment rates – consistently above the
  - state rate over time
    - Approx. 2,050 unemployed workers in 2018; down from a peak of 3,800 in 2009-2010
    - Smallest number of unemp.
      workers since 2000



# **Labor Force Characteristics**

- Region 2 has much lower labor force participation rates than the state; but the older population led to lower overall rates
  - Down from 63.3% in 2000
- Workers of other races or origins jumped +55.5% from 2000 to 2017
  - Accounted for almost two-thirds of net new workers
- 84% of workers are white
  - 2<sup>nd</sup> most racially diverse workforce in the state
  - But all other race groups have higher unemp. rates than whites
- Lower partic. rates for workers with disabilities
  - But higher unemp. rates

# Labor Force Trends: Gaps & Challenges

- Despite projected population growth, long-term projections show a decline in the labor force
  - -117 workers from 2020-2030
  - Huge decline in Baby Boomers reaching retirement age
- Getting workers of all other races, workers with disabilities, and workers with less than a H.S. diploma to the white unemp. rate would fill 1,170 jobs without affecting labor force size

# **Student Enrollment Trends**

- How many K-12 students are there in Region 2?
  - 13,760 students (at public schools) in 2017-2018
    - +4.3% from 2008-2018
  - 5,452 minority students 39.6% of total students (state = 33.5%)
    - +39.6% from 2008-2018
- Two groups of seniors what are you going to do with your life?
  - "Seniors" refers to 12<sup>th</sup> graders, and anyone aged 55 years & older(?)
  - 15,265 people from 55 to 67 years
  - EDR 2 has more "seniors" than
    "seniors" in all but one grade level



# **Student Plans**

What percent of H.S. graduates in Region 2 go to college?

- 59% of students in 2017 graduating year (state=69%) Headwaters Economic Development Region High School

- 44% stay in Minnesota; 15% outside Minnesota
  - 27% go to Public 2-year; 33% to Public 4-year;
    26% go outside MN; 11% to Private 4-year
- What is the most attended college?
  - Bemidji State University (16%)
  - North Dakota State University (10%)
  - Minnesota State Community & Technical College (6%)
  - Northwest Technical College (6%)
  - Minnesota State University, Moorhead (5%)
- Only 46% of minority students go to college
   (state = 60%)
- Likewise, only 47% of students on free & reduced price lunch go to college (state = 53%)
- 83% of students who took rigorous courses
  - But 26% go outside Minnesota
- 27% of students go straight to work
  - The largest number go into Trade, Transportation & Utilities and Leisure & Hospitality




# **Incomes & Cost of Living Tool**


- What is the basic needs cost of living for a Single person with no children?
  - **\$27,612**
  - Required Hourly Wage = \$13.28
- What is the basic needs cost of living budget for a typical family?
  - \$46,872 (state = \$55,548)
  - Hourly Wage Req. = \$15.02



#### **Economic Growth**

- Region 2's economy has seen ups & downs in the past decade
  - Added nearly +2,000 net new jobs (+6.4%) since 2003 (state = +11.8%)
  - Added +2,082 jobs (+6.9%) from 2013-2018 (state = +7.0%)
  - +465 jobs (+1.5%) from 2017-2018 (state = +1.0%)



#### **Economic Growth**

- Health Care & Social Asst. is the largest industry, with 6,143 jobs (19.1%)
  - Added +607 jobs from 2013
- Retail Trade & Acc/Food Services offer 7,989 jobs
  - Provide 25% of jobs!
  - Low wages, high growth
- Educational Services has 3,446 jobs (10.7%)
  - +245 jobs from 2013
- Public Administration has 2,984 jobs (9.3%)
  - +336 jobs from 2013
- Manufacturing has2,559 jobs at 79 firms
  - 8% of total jobs
  - (state = 11%)
